At the Board meeting we discussed, amended, and approved the proposed Bylaw changes for General Membership review. The Bylaws are included in this edition and will be read at the Meeting on Wednesday to be acted on at the May meeting. The Women's Issues reported they provided a \$1500 grant to Bethel Outreach Ministries and the Boys and Girls Clubs of Cheyenne. The Youth and Family raffle netted \$316 for the Jewelry which was then donated to Safe Harbor for new toys. We collected 18 Peanut Butter and 14 Jelly for Needs last month. Your Board continues to work on your behalf.

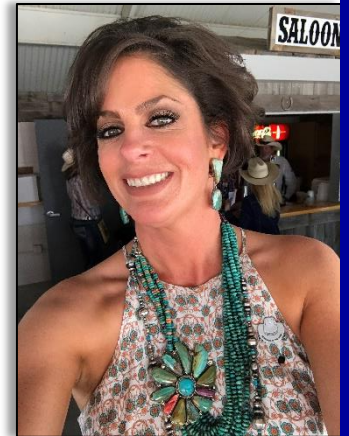

BYLAWS

GFWC WOMEN'S CIVIC LEAGUE OF CHEYENNE BYLAWS AND STANDING RULES *Revised and Adopted, May 2019*

ARTICLE III. Membership

Section 3. Active Members

- a) An Active member shall be required to be a member in good standing as outlined in the Standing Rules.
- b) ~~Members have a standing luncheon reservation for General Membership meetings.~~ Active members shall pay for any meal reservation that is not cancelled five (5) days prior to the luncheon.
- c) Members in good standing must comply with all financial responsibilities of the Club, including the payment of annual dues, **and have no unpaid meals or unpaid Christmas House tickets.**

RATIONALE: To clarify.

Section 5. Associate Members.

- a) An Associate membership shall be available to any member who has completed seven (7) years of Active Membership. A letter requesting Associate status must be submitted to the Membership Chairman ~~by April 1 to become effective the following September.~~ **to be voted on at the next regularly scheduled Board of Directors meeting. If approved, the change to Associate member status will be effective the day it is approved by the Board.**
- e) Associate members desiring to return to Active status ~~must make written application, in the form of a letter, shall notify the Membership Chair in writing to the Membership Chairman by April 1. The Membership Chairman will then take the application to the Board of Directors for approval. Associate members shall be eligible to return to Active status only at the September meeting of each Club year.~~ **Requests to change to Active membership require the approval of the Board of Directors. All membership changes from Associate to Active will become effective at the September meeting of each club year. The Membership Chairman shall provide send Associate members a courtesy letter or email no later than by March 1 annually, of the date by which their dues must be paid, the amount of their dues and Christmas House financial obligations, and to whom their checks must be mailed.**

RATIONALE: To simplify and clarify status changes.

Section 9. Transfers and Reinstatement

- d) ~~Resigned members and m~~Members **who resign or are dropped when** not in good standing, ~~when dropped,~~ and wish to return to membership must be sponsored in the usual manner.

RATIONALE: To clarify.

ARTICLE IV. Officers

Section 3. The First Vice-President shall, in the absence of the President, perform the duties of that office. She shall succeed to the office of President. She shall be Program Chairman for General meetings and shall chair the Allocations **Review** Committee. She shall appoint the Community Grant Committee (CGC) co-chair who will serve as the CGC chair during her term of office **as President**. She shall also appoint the Chair of Christmas House **who will serve during her term as President**. She shall act as coordinator of all community service program committees.

RATIONALE: To clarify

Section 7. The Treasurer

- f) She shall be custodian of the Club funds and papers pertaining to her office. **All records shall be transferred to her successor by May 31, annually, upon installation of a new Treasurer.**

RATIONALE: To clarify.

ARTICLE V. Meetings, Rules, Voting and Quorums

Section 1. GFWC Women's Civic League of Cheyenne will hold its General Membership meetings on the second Wednesday of each month from September through May, at a time and place designated by the Second Vice-President, in coordination with the President. Exceptions will be noted in the yearly calendar. **Meetings may be suspended by the Board of Directors due to inclement weather or a national or state emergency. Meetings may be held virtually at the direction of the Board of Directors.**

Section 3. Preceding each General membership meeting, the Board of Directors shall meet at a time and place designated by the President. A simple majority of the Board of Directors present shall constitute a quorum. A two-thirds (2/3) majority of those present is required for passage of a vote. **Meetings may be suspended by the Board of Directors due to inclement weather or a national or state emergency. Meetings may be held virtually at the direction of the Board of Directors.**

RATIONALE: To adjust bylaws for any future crisis such as the pandemic.

Section 7. The fiscal year for GFWC Women's Civic League of Cheyenne as approved by the IRS to be July 1 through June 30.

RATIONALE: To add the fiscal year to the bylaws.

ARTICLE VII. Committees

h) Christmas House Project Committee

- vi) No more than ~~3%~~**5%** of any committee's Christmas House allocation may be used outside Laramie County, ~~excepting the International Outreach Community Service Program.~~

RATIONALE: To allow each committee to use funds for International Outreach.

Section 2. Community Service Program Committees.

- a) **Arts and Culture Community Service Program.** This committee shall promote and support all community aspects of **projects that include** creative arts such as crafts, music, literature, drama, dance,

and other visual and performing arts **that develop skills, awareness and appreciation.**

- b) ~~Conservation Environment Community Service Program.~~ This committee shall ~~promote an appreciation for our environment and educate Club members, through preservation, maintenance and restoration of our natural resources, including but not limited to projects such as recycling, street cleanups and historic preservation.~~ **suggest activities and projects that encourage members to become stewards of the earth, working to preserve the world's resources, protect wildlife and domesticated animals, live sustainably, beautify our community and enjoy nature.**
- c) **Education and Libraries Community Service Program.** This committee shall promote education through scholarships and projects for Laramie County residents. Additional programs may be supported for, but not limited to, overcoming learning disabilities, supporting local libraries, promoting literacy, mentoring young people and encouraging lifelong learning.
- d) ~~Home-Life~~ **Health and Wellness Community Service Program.** This committee may provide resources through volunteering to meet and address ~~needs such as hunger, inadequate housing and homelessness, personal development, healthy lifestyles, prevention and treatment of diseases, education on women's health, service dog programs, child care, substance abuse and domestic violence as well as other issues.~~ **nutrition, disease prevention, and physical and emotional care.**
- e) ~~Civic Engagement and Outreach Community Service Program.~~ This committee may actively connect members with effective programs and activities related to social and civic responsibilities. The committee may promote citizenship/legislative education and involvement, military outreach, emergency and disaster preparedness, and safety and crime prevention. This committee may encourage Club members to become better world citizens through advocacy, education and action to make a positive global impact. **This committee encourages member participation in the areas of citizenship, crime prevention, safety and disaster preparedness; supporting the military and their families; and assisting the needy, hungry, and homeless.**
- f) ~~International Outreach Community Service Program.~~ This committee may encourage Club members to become better world citizens through advocacy, education and action to make a positive global impact. These programs assist in raising cultural awareness.

RATIONAL: To conform to the current GFWC program committee names.

STANDING RULES

Adopted May 2019

Note: The Article or Section number refers to the corresponding Bylaw (i.e. ARTICLE S-II. Mission refers to Bylaw Article II. Mission). All Bylaws Sections and Subsections do not have a corresponding Standing Rule.

Section S-4. Second Vice-President.

- b) She shall appoint the hostesses for the General Membership meetings, arrange the menus and in consultation with the President, sign contracts with vendors for General Membership meetings. **She or her designee shall contact all active members for General Meeting reservations via the electronic reservation system or a personal phone call. She shall send a personal note to any active member to whom she is unable to contact.** She performs any other necessary duties pertaining to the social arrangements of the meetings. She shall work with the treasurer to collect all monies associated with the luncheon and prepare a written report after each meeting for the following board meeting to be attached to the treasurer's report. She assists in the selection of a Chairman for each Club Activity

Group. She shall provide all necessary information regarding meetings to the Yearbook Chairman and the Publicity/ Communications Chairman by July 1.

RATIONALE: To adjust for the current procedures.

Section S-2. Community Service Program Committees

Committee chairs are encouraged to use whatever format necessary to elicit suggested project ideas from their members. **Any committee may work on special projects at the local, state, national and international level that promote cultural and international understanding.**

Disbursements from the Community Service Program allocations require committee approval.

ii) Any funds remaining after May 31, will revert to the Community Grant Committee. Upon request, exceptions may be granted by the Board of Directors. If a committee wants to earmark funds beyond the current budget year for a specific project, they must bring the issue to the Board which will have the authority to decide issues regarding the holdover of funds to the next year.

The Community Service Program Coordinator shall meet with the committee chairmen. She may chair the ~~Home Life Community~~ **Health and Wellness** Service Program Committee. She may choose her own co-chair.

b) **Conservation Environment.** The committee may advise the membership concerning local and national environmental, recycling, and conservation activities which may be of interest.

c) **Education and Libraries.**

i) In addition to relevant educational projects, the committee is responsible for awarding scholarships to high school seniors from Laramie County to be used at the Laramie County Community College, the University of Wyoming, or any Wyoming college or licensed or accredited technical or trade school. The committee may also award scholarships to LCCC non-traditional, female student(s).

ii) The Epsilon Sigma Omicron (ESO) subcommittee is an honorary educational society endorsed by GFWC that provides clubwomen with a structured reading program that is educational and stimulates a desire for self-improvement through literacy.

c) ~~Home Life.~~ **Health and Wellness** The chairman will meet with all sub-committee chairmen to determine each sub-committee Christmas House allocation distribution.

i) There may be a Special Needs subcommittee to support and enrich the lives of people with special needs, to be described as people with developmental, physical, mental and brain injury disabilities.

ii) There may be a Youth, **Women** and Family Services subcommittee to support a variety of youth, **women** and family programs that promote literacy, citizenship and support in developing and maintaining healthy family lifestyles.

~~iii) There may be a Women's Issues subcommittee to serve as an advocate and champion for the improvement and well-being of women and shall assure that a portion of GFWC Women's Civic League of Cheyenne's time and resources shall go towards benefiting women in the community.~~

iv) There may be Senior Services subcommittee to support a variety of programs that promote independence, enrich the quality of life, and promote support for the elderly and their caregivers in the Laramie County community.

v) There may be other committees as deemed appropriate.

d) ~~Public Issues~~ **Civic Engagement and Outreach.** The chairman will meet with all sub-committee chairmen to determine each sub-committee Christmas House allocation distribution.

i) There may be a Legislative subcommittee to advise the membership concerning activities of

governmental entities which may be of interest to the membership.

- ii) There may be a Military Outreach subcommittee to assess and support the needs of the military, military families and military retirees of the community.
- iii) There may be a Substance Abuse subcommittee to provide drug and alcohol prevention education, to work to develop projects, and to partner with other organizations to support individuals and families dealing with addiction issues.
- iv) There may be other committees as deemed appropriate.
- v) ~~This committee may work on special projects such as Operation Smile, Heifer International, and other projects deemed appropriate.~~

- e) ~~**International Outreach.** This committee may work on special projects such as Operation Smile, Heifer International, and other projects deemed appropriate.~~

What Is Arbor Day?

While Arbor Day and Earth Day are often mistaken for one another, they represent two different, but very important themes. Established in Nebraska in 1872, Arbor Day can be observed on the last Friday in April every year. Nebraska newspaper editor-turned-senator J. Sterling Morton proposed the holiday, when he, along with other settlers from the East Coast, noticed the territory's lacking tree population.

The idea quickly caught on and today it's celebrated simply by planting trees and showing appreciation for the environment. You can participate in Arbor Day activities by planting your own tree and supporting companies with tree-planting initiatives.

As a matter of fact, the makers of Quilted Northern® toilet tissue have partnered with [Partnered With Arbor Day Foundation®](#) to plant two trees for every one used in the production of Quilted Northern Ultra Soft & Strong®. 2. The very first Earth Day fell on a school day and in observance, students came together and planted flowers, committed to recycling and protested pollution.
3. On the first official Arbor Day on April 10, 1872, Nebraskan citizens planted more than one million trees.
4. Arbor Day became a legal holiday in 1885 with an official date of April 22 (the same as Earth Day!) but was later moved to the last Friday in April and can vary depending on the region. For example, Hawaii's tree-planting season is ideal towards the end of the year so citizens plant trees in observance of Arbor Day on the first Friday in November.
5. These environmentally conscious holidays influenced the passing of the Clean Air Act, the Endangered Species Act and prompted the creation of the Environmental Protection Agency.

Interestingly, while most holidays acknowledge a past event, Earth Day and Arbor Day focus on celebrating possibility for the future. By learning about these important eco-friendly holidays, we can work together to preserve our planet's precious resources and commit to products and organizations that also share the same vision.
