- 2. Whereas, Article 7, of the said Certificate of Incorporation provides as follows:

"The term of existence of this corporation is fifty years, and "

- 3. Whereas, the Statutes of the State of Wyoming, Sec. 17-122 (b) as Amended, now permit the term of this and other non-profit corporations to be perpetual.
- 4. Whereas, the said Articles of Incorporation, Article 4, provides that

"At any meeting of the Federation, by a vote of the majority of the members present, as shown by a report of the Committee on Credentials of said meeting,... these Articles of Incorporation may be amended."

5. Whereas the present pertinent Wyoming Statute, Sec. 17-122.11 as Amended, provides "Any non-profit corporation organized under the laws of this State may Amend its Certificate of Incorporation or Articles of Incorporation by the affirmative vote of 2/3 of the members present at any regular or special meeting called in accordance with the by-laws. . "

And, in conclusion, that for and in the best interests of the Wyoming Federation of Women's Clubs, this amendment and change should be made.
